



Approved Suppliers: Butt Weld and Socket Weld Fittings

Please Note:

If BW/SW fitting is also a Forging (EB-2678) or a 70/30 CuNi casting, Seller shall ensure the Forging house and CuNi foundry are also on the approved lists for Submarine Forging Suppliers and Foundries to Produce 70/30 CuNi Castings.

Seller shall flow down the substance of this provision to all of its suppliers for the procurement of materials contained within this Pervasive Commodity provision in each sub-tier purchase order.

Manufacturers, Distributors, Primes, & etc. must submit a VIR for approval to use a manufacturer who is not on the Pervasive List. Mechanical (post heat-treat final conditions) and chemical test reports are to be submitted with the VIR for NNS Engineering approval.

Fitting Requirements

The Seller shall procure Butt Weld and Socket Weld pipe fittings from the supplier sources listed on the approved supplier list. Approval is provided for the supplier source, supplier number and location identified as listed. If a location is not listed, that location is not approved. Butt Weld and Socket Weld Pipe Fittings provided by an approved Distributor must be manufactured by one of the approved manufacturers for Butt Weld and Socket Weld Pipe Fittings. The Distributor is responsible for ensuring that delivered items are in full compliance with the terms and requirements of the Purchase Order. This includes reasonable and sufficient oversight over the subtier manufacturing base.

Fittings include, but are not limited to, belled-end fittings, parts of standard dimensions used in the assembly of a piping system, such as couplings, elbows, tees, crosses, caps, unions, **and reducers.**

This applies to all Material Control Levels identified in the NNS Purchase Order through the 'Material Group' designation except for "CM-FAC". These Material Control Levels are MC-I, CM-II, CM-III, CM-A, CM (-), and STD.
