Newport News Shipbuilding will be closed for the Holiday from Wednesday, December 24, 2025 through Sunday, January 4, 2026 and will reopen on Monday, January 5, 2026.

## **Escort Service**

 Truck escort service to enter the yard at NNS will stop at 6 p.m. on Tuesday, December 23, 2025.

Main Receiving - 2175 Aluminum Avenue, Hampton, VA 23661, Bldg. B

- Last day for normal deliveries will be 2:00 p.m. on Thursday, December 18, 2025 for all carriers- Full Truckload and LTL (Less-Than-Truckload).
- Local Carriers will be advised to hold LTL shipments during the shutdown until Monday, January 5, 2026.
- Any suppliers or carrier attempting to make Truckload deliveries during the holiday shutdown period should be directed, by Security, to return to Receiving after Monday, January 5, 2026 or contact Miller Transfer to make arrangements for delivery.

- All packages delivering to a NNS address over shutdown will be redirected to Main Receiving and be delivered via O54 and Mailroom personnel on January 5, 2026.

- When possible, arrange for FedEx shipments to arrive prior to Tuesday, December 23, 2025 or after Main Receiving opens on Monday, January 5, 2026 to minimize extra handling at NNS.
- Emergent material shipments to be received after Thursday, December 18, 2025 must have Sharonda Newby's (757) 510-8415 approval to be accepted.
- For emergent material needed over shutdown or startup that can't be received before shutdown or the days Main Receiving is open during shutdown, the Logistics team will support - Contact Tequetta Davis at (757) 814-4733 or Standby personnel at (757) 880-3514 to coordinate.
